

Tanfac Industries Limited Announces Successful Commissioning of its second phase of 5,000 TPA (AHF Basis) High Purity Solar Grade DHF Plant

Chennai, October 6, 2025: Tanfac Industries Ltd. (BSE- 506854, ISIN: INE639B01015), one of India's leading players in Fluorine Chemicals, has successfully commissioned its second phase of 5000 TPA (AHF Basis) Solar Grade Dilute Hydro Fluoric Acid Plant on 6th October 2025 post approval of the quality of the trial production batches after the product conformed to the stringent quality requirements of its customers. Tanfac had already commissioned the first phase of the project in June 2025 (5,000 TPA – AHF Basis), expanding the total Solar Grade DHF capacity to 10,000 TPA (AHF Basis).
